## State Auditor Otto convenes Minnesota Volunteer Fire Relief Association Working Group

ST. PAUL (10/23/07) – State Auditor Rebecca Otto convened the 12-member Minnesota Volunteer Fire Relief Association Working Group for its first meeting today. The purpose of the Working Group is to bring together volunteer fire relief association stakeholders to develop relationships, facilitate communication, and work on relief association issues before the legislative session.

"The Working Group will identify and work through current and pressing relief association issues that affect thousands of volunteer firefighters across the state," State Auditor Rebecca Otto said. "Our goal is to make the pension process easier and more effective, and we are fortunate to have assembled a group of very knowledgeable and engaged stakeholders to help us in that effort."

Relief association trustees throughout Minnesota have forwarded suggested topics for the group to consider. Over the course of 5 meetings this fall, the Working Group will discuss and make recommendations to clarify state laws, simplify reporting forms, and address training and other issues. The group will forward suggested statutory changes upon consensus to the Legislative Commission on Pensions and Retirement.
