Rebecca Otto Receives 2014 NASACT President's Award

Santa Fe, NM – August 11, 2014 – Today Rebecca Otto, state auditor of Minnesota, was named as a recipient of a President's Award from the National Association of State Auditors, Comptrollers and Treasurers (NASACT).

The President's Award is given each year to one state auditor, one state comptroller and one state treasurer to recognize exceptional efforts in government financial management and accountability.

State Auditor Otto was honored with the award to recognize her national leadership as president in 2013-14 of the National State Auditors Association and her efforts to improve government operations as one of NASACT's representatives on the national Alliance to Transform State Government Operations (Alliance).

As a member of the Alliance, Otto participated in a summit that produced a white paper entitled "Transforming State Government from the Inside Out." The white paper was released in March 2014.
