The CTAS Upgrade

People receiving this newsletter will be mailed a CD containing the Diamond Edition (Version 6) of CTAS. The new version will be mailed in late March. If you know of a CTAS user that does not receive this newsletter, please inform them that they need to notify the Office of the State Auditor to receive a copy of the new version

The following is a list of some of the enhancements that were made.

- Third rate and fourth range for the Federal Income Tax withholdings.
- Payroll register printed landscape. All employees are printed on one page.
- Asterisks before the amount on checks, for example, **23.47.
- Check date printed on payroll check stub.
- Full name on Interim Financial Statements used to identify which statement is printed.

- Inactive funds If a fund is marked inactive, it would not print on the current years financial statements.
- Store prior year beginning balances. This would allow the printing of all prior year reports.
- Select which of the employee W-2s to print.
- Delete individual employee records from a payroll period.
- Print Schedules 4 and 4A Enterprise Funds for financial statements.
- Indebtedness Module –
 will allow the user to track
 the indebtedness in a
 manner similar to the
 investments.
- When entering check numbers in payroll and claims, the first prompt will be for the date.
- Outstanding Checks Report – Print a list of outstanding checks.

- Allow changes to the Account Distribution of a Claim after the claim has been posted.
- In receipts and disbursements, include the option of searching by an amount.
- Includes an option to select the number of copies to be printed for each report.
- Includes the information on investments on Schedule 1.
- Allows CTAS to memorize recurring transactions.
- Create a report that will print the employee information.

In addition to these proposed changes, there will be the ability to select the Windows XP operating system when installing CTAS. This should correct some of the printing issues we have with the checks and W-2s.

Training

The Office of the State Auditor offers training sessions on the CTAS system. This is a basic beginners course designed for those users that have limited or no experience using CTAS.

After receiving CTAS, you may register for this training. Registered users are notified of the training dates in the CTAS newsletter.

These sessions are held at the State Auditor's Office in St. Paul. A training session is scheduled for April 6, 2005. The training session begins at 9:00 a.m. and ends at approximately 1:00 p.m.

Please call Ms. Debra Schultz at (651) 297-3688 to register for the training session. The resources available for training require that we have a maximum of eight people for a session. Due to the time and resource commitment, the Office of the State Auditor reserves the right to cancel a training session if registrations do not exceed four.

Participants should bring their Reference Manual to the training session. A training workbook is provided.

The training session will be held at the State Auditor's Office, Suite 500, 525 Park Street, St. Paul, MN. Directions to our location may be obtained from the Office of the State Auditor's website. Parking is available across the street in the Bethesda Ramp.

Tax Rates for New Version of CTAS

Version 6 of CTAS will add an additional range for the Federal income tax withholdings. The new information is as follows:

Single:

Range 1: 2,650 Range 2: 9,800 Range 3: 31,500 Range 4: 69,750 Withholding 1: 715 Withholding 2: 3,970

Married:

Range 1: 8,000 Range 2: 22,600 Range 3: 66,200 Range 4: 120,750 Withholding 1: 1,460 Withholding 2: 8,000

Rates:

First: 10% Second: 15% Third: 25%

Remember, the tax rates should be entered as a decimal.



New City Reporting Manuals

The Office of the State Auditor has issued two new reporting and publishing requirements for cities reporting on a cash basis.

The first manual is for cities reporting on a cash basis. This is for cities that are not audited. The major change is Schedule 5 – Statement of Orders Issued is no longer required.

The second manual is for cities audited on a cash basis. This manual shows the financial statements required for an audit on the modified cash basis in accordance with GASB Statement 34. The manual also provides for filing the financial statements on a regulatory basis. Cities should check with their auditor to determine which basis is appropriate for their city.

The other major change is in the publishing requirements.

Minnesota Statutes now allows a summary financial statement to be published. The prescribed format for the summary statements is shown in both manuals.

- ► REMEMBER TO BACKUP YOUR DATA!
- ► CTAS Version 5 for Windows is a stand-alone system. A network version of the system is not available. The Helpline does not have the expertise to troubleshoot CTAS running on a network.
- ▶ When loading CTAS on a new computer, start with the CTAS V5 for Windows original CD. The updates do not contain the system files required to run CTAS. Windows XP users should select Windows NT 4.0 or Windows 2000 as the operating system.

☐ <u>Increase the Size of the CTAS Screen</u>
