Training

The Office of the State Auditor offers training sessions on CTAS. This is a basic beginners course designed for those users that have limited or no experience using CTAS.

These sessions are held at the State Auditor's Office in St. Paul. A training session is scheduled for July 7, 2005. The training session begins at 9:00 a.m. and will end at around 1:00 p.m.

Participants should bring their Reference Manual to the training session. A training workbook is provided.

The training session will be held at the State Auditor's Office, Suite 500, 525 Park Street, St. Paul,

MN. Directions to our location may be obtained from the Office of the State Auditor's website. Parking is available across the street in the Bethesda Ramp.

Information on the CTAS Diamond Edition

An Update is Coming

Our goal is to mail an update to CTAS Version 6 by the end of June. This update will correct issues with the original release including: The display issues with Windows 95, 98 and ME, the voided checks showing on the Outstanding Checks Report, Check printing issues, Backing up the data and CTAS not installing on older computers.

Error 510 –Backing up Data

Back up the data using a new or blank diskette. This issue will be resolved with the update.

Amount Exceeds Step 4 of the Tax Tables

Version 6 has added an additional step and rate. In the Tax Tables section of CTAS Payroll module you will need to enter the additional information. This information is provided on the State Auditor's website or in the Spring 2005 Newsletter.

Runtime Error – Cannot Find Database

Is there a CTAS-VB6 icon on your Desktop? If not, try installing CTAS Version 6 again. Also, the CTAS migration utility is set to use the defaults in versions 5 and 6. If you did not use the default setting for the databases, you will need to change the location of the databases.

Change Beginning Balances

Begin by clicking on the Cash Icon in CTAS. Then highlight the fund and click the Edit button. Enter the correct balance and click the Save button.

Sample Check

The sample check in CTAS is designed to assist users in lining up the checks on a dot-matrix printer. For CTAS users with a Laser or Inkjet printer, you can print the checks on plain paper. Checks can be printed until a check number is entered.

How do I delete an employee in a posted payroll?

- 1. Edit the Payroll Period
- 2. Click on the Create/Update Payroll Roster.
- 3. Highlight the employee to be deleted.
- 4. Click the Remove Button
- 5. Click the Save Button.

This should delete the employee from the payroll. Remember to delete or void the associated disbursement.

Enterprise Funds

In the CTAS Diamond Edition all Enterprise Funds must use a 600 number. These are funds such as Water and Sewer utilities. Using the 600 fund numbers for enterprise funds will create the correct electronic file for submission to the Office of the State Auditor.

To change the fund number, click on the Acct_no icon. Highlight the Enterprise Fund and click the Edit button. Change the number and then click the Save button. CTAS will change all transactions with this fund number.

What type of checks do I need to order for my Inkjet or Laser printer and are window envelopes available?

The type of check needed is Deluxe LaserJet Check form; Product Number 81064; Laser Multi-purpose Check 8 1/2 X 11.

Three check printers provide this format. They are:

Also, these printers have window envelopes available for the checks printed with the CTAS system.

Payroll Distribution Reports

The check date is used when printing the payroll distribution reports. Generally if you do not receive a payroll distribution report it is due to the check date. To review the check date, click on the Payroll icon. In the list box find the payroll period in question and review the check date.

Backing up to a CD

To back up CTAS onto a CD you will need to format the CD. The CD writer program I used was Roxio Easy CD Creator. With a CD inserted into the CD drive, I selected formatting a CD to drag and drop files from Windows Explorer. For Roxio, this selection was titled directCD. Then I selected Format CD and entered the label name for the CD. Then I clicked the Start Format button. With the formatting completed. I selected the CD drive in CTAS for backup and ran the backup. This created the backup file on CD.
