GASB Statement No. 34 Basic Financial Statements

In June 1999 the Governmental Accounting Standards Board (GASB) issued GASB Statement No. 34. This statement establishes new financial reporting requirements for state and local governments reporting in accordance with Generally Accepted Accounting Principles (GAAP).

Cities and towns required to report in accordance with GAAP must follow the financial reporting requirements outlined in GASB Statement 34. For cities and towns using CTAS the effective date for implementing GASB 34 is for the year ended December 31, 2004. Unless their 1999 annual revenues exceed \$10 million.

Currently, state statutes allow towns to report on

the cash basis of accounting. For those towns that are or will be audited on a cash basis, some GASB 34 requirements may apply. However, no changes are expected for towns that are not being audited. In either case, we will keep you informed as the reporting requirements become more defined.

Cities reporting on the cash basis should expect some minor changes in the reporting requirements. To meet the implementation date of December 31, 2004, changes in the reporting requirements will be available in time for cities to make the necessary adjustments to their financial statements.

Cities and towns required to report on the GAAP basis of accounting should take steps to properly account for their fixed assets. This may include the purchase of software. GASB 34 requires state and local governments to

record infrastructure as fixed assets. Infrastructure includes streets, roads and bridges.

- 8. All Screens can than be closed
