# The CTAS Update Version 6.0.8

Available for download is version 6.0.8 of the CTAS software. This update corrects the calculation of the receipts and disbursements when the State Auditor file is generated.

In addition, Schedules 4 and 4A have been updated. Schedules 4 and 4A are financial statements for enterprise funds, such as water and sewer utilities. If you do not have enterprise funds, there is no need to print these financial statements.

Unless you have only 2005 data on CTAS, Version 6.0.8 must be downloaded before you submit your electronic file to the Office of the State Auditor. For assistance in downloading the update or submitting your information electronically, please call the Helpline.

# **Training**

The Office of the State Auditor offers training sessions on the CTAS system. This is a basic beginners course designed for

those users that have limited or no experience using CTAS.

These sessions are held at the State Auditor's Office in St. Paul. A training session is scheduled for April 6, 2006. The training session begins at 9:00 a.m. and ends at approximately 1:00 p.m.

Due to the time and resource commitment, the Office of the State Auditor reserves the right to cancel a training session if registrations do not exceed four.

Participants should bring their Reference Manual to the training session. A training workbook is provided.

The training session will be held at the State Auditor's Office, Suite 500, 525 Park Street, St. Paul, MN. Directions to our location may be obtained from the Office of the State Auditor's website. Parking is available across the street in the Bethesda Ramp.

## Email

## **2005** Cash City **Financial Reporting**

The instructions, for reporting your 2005 financial information, have been mailed to all cities. Your OSA code can be found on the letter you received with the instructions. The deadline for cities reporting on a cash basis is March 31.

Cities that are being audited should not submit the information using CTAS. The Office of the State Auditor has reporting programs that cities should use to report their financial information. Also, the audit report must be submitted electronically using the Adobe Acrobat format (PDF).
