## 4. Update: CTAS 2020 Tax Tables Updated

#### 5. Reminder: TIF Four-Year Knockdown Rule

TIF authorities must submit evidence to the county auditor by February 1 of the fifth year following certification of a TIF district that activity in accordance with the TIF plan has occurred on parcels in the TIF district. County auditors must then review this evidence and enforce the Four-Year Knockdown Rule if no activity has occurred on a parcel. To learn more, please visit:

# 6. Reminder: 2019 Law Enforcement Agency Asset Forfeiture Reporting

Please remember to report all forfeitures that were completed in 2019 to the Office of the State Auditor (OSA) by January 31, 2020. Reporting must be done using the online reporting tool available in the State Auditor's Form Entry System (SAFES) at:

If you agency had no forfeitures completed in 2019, you will still need to login to SAFES and select the button labeled "I have no forfeitures in 2019 to report for this entity," by January 31, 2020.

## 7. Avoiding Pitfalls: Plowing Snow on Private Property

Counties and towns have statutory authority to remove snow from private property. The county or town must be paid not less than the cost of the snow removal, and the work must not "unduly delay or interfere" with the removal of snow from public highways under the county or town's jurisdiction. The relevant statute is Minn. Stat. § 160.21.

Some statutes relating to snow removal from roadways apply to specific entities, such as the statute for St. Louis County found at Minn. Stat. § 383C.234. Cities should consult with their attorneys to clarify the scope of their authority to remove snow from private property.

Additionally, counties, towns and cities have specific authority to adopt an annual resolution to remove snow from certain unopened or private roads in uncompleted subdivisions. The provision is found in subdivision 6 of Minn. Stat. § 160.21.
