*A RESOLUTION AFFIRMING THE CITY'S PARTICIPATION IN THE OFFICE OF THE STATE AUDITOR'
VOLUNTARY 2012 PERFORMANCE MEASUREMENT PROGRAM*

WHEREAS, the City of Aurora is a municipal corporation organized and existing under the laws of the State of Minnesota; and

WHEREAS, the 2010 State Legislature enacted legislation calling for the Council on Results and Innovation to establish a standard set of performance measures for cities; and


WHEREAS, such performance measures will aid residents, taxpayers, and state and local elected officials in determining the efficacy of cities in providing services; and

WHEREAS, the Council has established these performance measurements and is soliciting, through the Office of the State Auditor, voluntary participation in the 2012 effort; and

WHEREAS, in addition to the results generated from participation, benefits to participating cities include remuneration of \$0.14 per capita and exemption from levy limits for the participating year; and

NOW, THEREFORE, be it resolved by the City Council of the City of Aurora, that the City does hereby affirm its intention to participate in the Office of the State Auditor's Voluntary 2012 Performance Measurement Program and adopts the performance measures developed by the Council on Results and Innovation.
