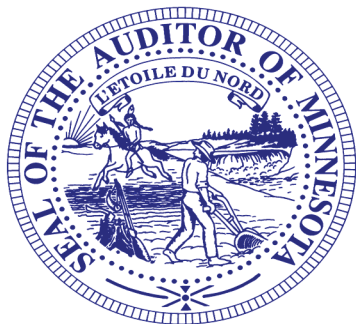


# TIF Division Newsletter



## 2007 TIF Reporting

We'd like to thank the 431 TIF authorities who filed complete 2007 TIF Reporting Forms by the statutory deadline! This year, 97.3% of the TIF authorities filed on time, an increase from 92.6% last year.

Those authorities that have not yet filed their 2007 TIF Reporting Forms must have the reports filed by October 1, 2008 to avoid having tax increment withheld by the county. If you have any questions related to the 2007 TIF Reporting Forms, please contact Jenna Ofstie or Marsha Pattison.
