Resolution declaring adoption and implementation of State performance measures

WHEREAS, the State Legislature created the Council on Local Results and Innovation which set a standard set of ten performance measures for cities that will aid residents, taxpayers and state and local elected officials in determining the efficiency of local services; and

WHEREAS, the city of New Hope has participated in the new standards measure program voluntarily since 2011 and wishes to do so again in 2015, and the city may be eligible for a reimbursement and exemption from levy limits; and

WHEREAS, the city has adopted the following performance measures:

- 1. Rating of the overall quality of life in New Hope
- 2. Percent change in the taxable property market value
- 3. Citizens' rating of the overall general appearance of their neighborhood
- 4. Bond rating
- 5. Citizens' rating of the quality of city recreational facilities
- 6. Part I and II crime rates
- 7. Citizens' rating of police protection in the community
- 8. Average police response time
- 9. Insurance industry rating of fire services
- 10. Citizens' rating of the fire protection services
- 11. Fire calls per 1,000 population
- 12. Average city pavement condition rating
- 13. Citizens' rating of the pavement repair and patching on city streets
- 14. Citizens' rating of the quality of snowplowing on city streets
- 15. Citizens' rating of the taste and quality of city water supply
- 16. Citizens' rating of the dependability and quality of city sanitary sewer service
- 17. Number of sewer blockages on city system per 100 connections

WHEREAS, the city is conducting a professional city survey in 2015 which will be conducted by The Morris Leatherman Company, and the results of the survey will be submitted in addition to the statistical information outlined above.

NOW, THEREFORE, BE IT RESOLVED that the New Hope City Council will continue to report the results of the performance measures to its citizenry by the end of the year through publication, direct mailing, posting on the city's website, or through a public hearing at which the budget and levy will be discussed and public input allowed.

BE IT FURTHER RESOLVED, the city of New Hope will submit to the Office of the State Auditor the actual results of the performance measures adopted by the city.




	How would you describe your overall feeling of safety in the city?


	How would you rate the overall quality of fire protection services in the city?






	How would you rate the overall quality of snowplowing on city streets?




	How likely would you be to use public transit if it was readily available?







	How would you rate the dependability and overall quality of city sanitary sewer service?
